In **creating excellent workplaces for our 365 employees**, we made **\$1,113,607 in capital improvements** in 2016, including new AccuDose machines, anesthesia monitors, chemistry analyzers, colonoscopies and video towers, hospital beds, OR tables, physical therapy tables, ultrasound machine and more; and we managed and distributed an **annual payroll of \$20,434,919**.
